**SUBJECT: ISEPC Participation in Who's Next (Paris) from 8-10 September 2024**

Dear Members,

**This has reference to this Council's Circular bearing No** ISEPC Cir No. 103/Sept24Who's Next-Paris/2024-25 dated the 8<sup>th</sup> April, 2024 on the subject, keeping in view of the interest of repeat participation in the fair, The Council has received overwhelmed response from Members / Designers and new Members for participation in the world-renowned Textile Fair in Sept 2024.

We had also mentioned in the above circular dated 8/4/2024 that the prices offered are subject to the approval of MAI grant that was Rs 3.30,000 for a 9 sqmt stand, and without Govt MAI grant, but with Council's Grant the price for the same was mentioned as **Rs 5,45,000/-, which are applicable to all.**

Please be informed that the Sub Committee at Govt of India has recommended our case to the appropriate authority for this fair but the final authority has not approved this activity. We have taken up the matter with the highest authority again requesting them to approve this Council's proposed MAI event and sanction the grant for this activity which we are following up with them.

Since as on date this activity has not approved by the MAI, Govt of India and hence, we have to charge our member as under;

1	<b>NOW APPLICABLE</b> Rate for 9 sqmt stand with Council's subsidy and every member have to remit the amount with application, which is still quite cheaper in comparison with the rate as for the Direct participation (non corner stands)	Rs 5,45,000/-
2.	Price of direct participation for BRAND participants	7865 Euro x 93 = Rs 731445
3.	Price of direct participation for MANUFACTURER participants	7170 Euro x 93 = Rs 666810
4	Which is still cheaper by around for manufacture participant	Rs 122,000/-
5	Which is still cheaper by around for Branded participant	Rs 1,87,000/-
6	Corner stand charges	Rs. 80,000/-

We request all members who have confirmed their participation through this Council to pay the difference amount immediately or latest by the next week, as we have to send confirmation to the fair authority along with remittance, in respect of the confirmed participants.

As informed above, with our continuous pursuance with the higher authority of MAI at a later stage if they approve Govt MAI funding for this fair and the difference amount approx. (or whatever the grant is released) will be refunded to the confirmed participants and hence, in case, if the grant is not released then there will not be any liability to the ISEPC, but we are trying our best.
