Dear Members,

We are pleased to inform you that the Indian Silk Export Council is organizing Mega Silk Exhibition & Buyer Seller Meet in UAE for display of Silk & other silk allied products, **from 21-24 November 2021**, in association with the concerned Indian Mission and with the active support of the local Trade Bodies, Chamber of Commerce to develop exports of Silk & Silk blend and other Textile products to UAE, which is an emerging market in the WANA region. The participation of Indian companies in the exhibition cum BSM in UAE is supported by Ministries of Textiles / Commerce & Industry under the MAI Scheme of Govt. of India.

#### **Highlights of the Fair:**

# In connection with your participation in Mega Silk Exhibition and Buyer Seller Meet in UAE, kindly note the following:

- The participation will be limited to 50 member companies with heavily subsidized cost under MAI Scheme of Deptt of Commerce, Ministry of Commerce & Industry. Members from SC/ST/Women Entrepreneurs and SME will be given preference, as per the revised guidelines of MAI Scheme;
- Any extra requirements will have to be borne by the participants themselves;
- One company will be allocated one subsidized display table / booth only;
- Amount of registration charge doesn't include any expenses of representative/s of participants companies like airfare, visa charges, freight, transfer, vaccine and test charges, if applicable in visiting country, including any charges which are being levied by the visiting country, etc;
- A small common pool of Interpreters will be made available for helping participants and buyers. However, for an independent service of an interpreter, participants will have to use their own interpreters;

<u>Publicity & Promotion</u>: The event will be publicized extensively by the ISEPC. The Council will publicize the Fair suitably through a separate Exhibitors Catalogue, sending invites to relevant textile importers in UAE and adjoining economy, coordinate with the Indian Embassy to promote the event to the leading importers of textiles & clothing, among other publicity measures.

#### **Financial Grant:**

- As ISEPC is organizing participation of member-companies in Mega Silk Exhibition & Buyer Seller Meet at UAE under the revised MAI Scheme 2021 of Govt of India, all eligible participating companies have been offered MAI subsidy for reduced amount of registration charges, as above, subject to the fulfillment of certain conditions;
- Deptt of Commerce, Ministry of Commerce & Industry through ISEPC will provide to all eligible participants re-imbursement of costs of 2-way economy class airfares, subject to the fulfillment of certain conditions, as laid down by them, through their revised MAI guidelines. The reimbursement of cost of economy class airfare to eligible participants will be limited with a maximum ceiling, subject to approval of the Ministry of Commerce, under MAI Scheme.

#### Criteria for availing reimbursement of airfare:

- Reimbursement of airfare is eligible to the exporting company as per the revised MAI Guidelines and should have export performance, having the export turnover below Rs. 50 crores (FOB value) in the preceding Financial Year, subject to furnishing of required documents within the time frame and approval of the same by the Govt. of India;
- Members to have completed 12 months of Membership;
- It is permissible only to the participation Companies' regular Director / Partner/ Proprietor (as enlisted in the updated and valid IEC issued by the DGFT) or a regular Officer of the company on Senior Managerial Position (not admissible to a foreign national or a foreign passport holder);
- Travel Claim forms duly filled in and complete in all respects together with all documents as per MAI Guidelines, must reach to the Council within 30 days of completion of event, in physical form, under the prescribed attached proforma;
- Initial Application form for claiming re-imbursement of airfare should reach to Council 14 days prior to your departure date;

### **Conditions for availing MAI subsidy:**

- A member exporter can avail MAI benefit for participation in 3 approved events in a financial year. 4th time participation in the Fair will be allowed without MAI subsidy. In the case of member belonging to SC/ST/Women and the exporters' having FOB value of exports of or less than Rs.50 crore in the preceding year, 5 participations in a year is allowed, provided each one of these is in different market (e.g. Africa, LAC, WANA, ASEAN, etc)
- A member exporter can claim MAI benefit for participation in one booth only. Additional booths can be booked by the participant without MAI benefit (One booth per company only with MAI eligibility);
- Participants will be selected on a "First-come-first-Served" basis, on receipt of completed application form with the required fee;

## Last date of confirmation of participation is 5:00 pm on 12th November 2021

**Apply for participation:** Exporters registered with ISEPC can apply for participation. Members interested in the above event are requested to kindly fill up and submit "**Declaration Form**" together with a copy of updated and valid IEC copy with participation fee by way of Demand Draft / Cheque at par in favor of "**The Indian Silk Export Promotion Council**, payable at New Delhi, by return or physically and confirm the same, so that we can forward the names to the respective authorities. Incomplete application will be rejected summarily. The payment can also be sent through RTGS as per the Bank details:
