#### Eligibility for financial assistance under Market Access Initiative (MAI) revised scheme:

NOTE: The proposal has been submitted to the Ministry of Commerce, Govt. of India for MAI Grant and following is subject to the receipt of approval / sanction of Grant.

#### Number of participations allowed in an event/ in a year:

- (A) In order to ensure that the benefits of the Scheme reach a larger number of exporters, a **maximum of three** participations in a particular trade fair/exhibition would only be eligible for MAI assistance, i.e., members who have availed assistance three times (including past cases) for a particular fair/exhibition, thereafter have to participate in that fair on their own Applicants have to confirm this in writing that including this fair we won't be exceeding the limit of three times in a fair in our firm;
- (B) **MAI funding** support is only provided to a member/participant company for a maximum of three MAI events in a year. In the case of exporters belonging to SC/ST/Women and the exporters having f.o.b. value of exports of or less than **Rs.50 crore** in the preceding year, **5 participations in a year** is allowed, provided each one of these is in different market (e.g. Africa, LAC, WANA, ASEAN, etc).

Eligibility for financial assistance under Market Access Initiative (MAI) scheme shall be governed by the orders of the Ministry of Commerce & Industry. Since this will be a Govt sponsored MAI approved activity for abroad, GST is not being charged on "participation charges" and **TDS if deducted should be** @ 1 or 2%, since, the Council is leading the role of a coordinator / facilitator, and not receiving the payment as rental.

The Council reserves the right to accept / refuse participation to any applicant, in case not found eligible, as per MAI guidelines or it oversold under MAI Scheme, without assigning any reason, then the booth will be allocated on Council's Non Subsidies rates, as mentioned above.

Member Exporting Companies interested in corner booth are requested to kindly send us a separate cheque in favour of **The Indian Silk Export Promotion Council** payable at New Delhi along with confirmation form. Incase corner booth is not allocated to interested member companies, then their cheque will be returned as it is.

# Criteria for availing reimbursement of airfare as per the MAI Guidelines of Govt. of India to the eligible participants only on approval of the same by Govt:

- **Reimbursement of airfare:** Exporting company having the export turnover below Rs.50 crores (FOB value) in the last financial year;
- ♣ Members to have completed 13+months of Membership with this Council or any other EPC / Trade Body and is regularly filing Export returns;
- ♣ Travel claim is permissible only to the regular Director / Partner/ Proprietor or a regular officer of the company on Senior Managerial Position, (not admissible to a foreign national);
- ♣ Attached Travel Claim forms duly filled in and complete in all respects must be submitted to the Council immediately after completion of the event;
- ♣ Initial Application form for claiming re-imbursement of airfare should reach to the Council 14 days prior to your departure date to participate in the fair with NOC from the EPC / Trade Bodies;

#### Conditions for availing MAI subsidy:

- 4 An exporter can avail MAI benefit for participation in 3 approved events in a financial year, 4th time participation in the Fair will be allowed without MAI subsidy;
- 4 An exporter can claim MAI benefit for participation in one booth only. Additional booths can be booked by the member participant without MAI benefit-One booth per company;
- A maximum of three participations in a particular trade fair / exhibition would only be eligible for MAI assistance, i.e., members who have availed assistance three times (including past cases) for a particular fair/exhibition, from any other EPCs/ Trade Bodies, thereafter, must participate in that fair through Council's non subsidized booth;

#### Guidelines for allotment of Stands:

- All participants who have paid the full participation fee on time would be considered for allotment of booths;
- 2. No change in the booths, once allotted would be entertained under any circumstances;
- 3. In case of default of any payment due from the participants, ISEPC reserves the right to debar them from Participation in ISEPC's International Fairs and bring to the notice of appropriate authority;
- 4. Participants will be selected strictly on a "First-come-first-Served" basis.

**Apply for participation**: Exporters registered with ISEPC / EPC / TB can apply for participation in the above event are requested to kindly fill and submit the **"Declaration Form"** with participation fee by way of Demand / Neft / RTGS Draft in favour of **"The Indian Silk Export Promotion Council**, payable at New Delhi. **No Cheuqe payment will be accepted**.
