## Subject: ISEPC Circular on organizing participate in Two City Buyer Seller Meet cum display of Silk and silk blend with silk importers in South Africa - from 29-31 March 2023 Reg: (Postponed activity of last year)

#### Dear Members,

We are pleased to inform you that The Indian Silk Export Promotion Council (ISEPC), under the aegis of Ministry of Textiles & Ministry of Commerce, Government of India, is organizing India's National Level Participation in the Two City Mega Silk Exhibition cum Buyer Seller Meet in South Africa during 28-31. March 2023 in association with the concerned Indian Missions at Durban and Cape town and with the active support of local Trade Bodies, Chamber of Commerce to develop exports of Silk & Silk blend and other Textile products to South Africa, which is an emerging market for us and to celebrate and commemorate 75 Anniversary of Independence of India-Azadi Ka Amrit Mahotsav, and G-20 and through this exhibition we will highlight India's strength in the silk textile segment to project India as a "New India". The participation of member companies in the Mega Silk Exhibition cum BSM are supported by Ministry of Textiles, Ministry of Commerce & Industry, as well, under MAI Scheme to showcase our latest contemporary vibrant designer collections exclusively to Southern African chain store buyers, independent retailers, boutique owners, home textile & soft furnishing buyers, agents, wholesalers, importers and other industry professionals.

India has a diverse and rich textile tradition. It is the second largest producer of textile and clothing in the world with its products being exported to over 120 countries. Recent estimates indicate that the country's textile sector will grow faster in the coming years and contribute a lot to the overall economy.

Unlike in other regions of the world, the value of intra-Africa trade has remained low over the years. Moreover, Africa accounts for just 2 percent of global trade. In 2021, African countries launched the African Continental Free Trade Area (AfCFTA), which aims to create a single African market for the free movement of goods, services, labour, and capital, and increase intra-African trade. AfCFTA may be able to provide to our member firms and investors certain opportunities to tap into a larger, unified, and robust African market.

In terms of bilateral trade, the African Union is one of India's largest trading partners after the United States (US), China, and the United Arab Emirates (UAE). With a share of 8.52 percent in world trade, India's total trade with Africa in 2019 was valued at USD 68.33 billion.

#### In connection with your participation in the above, kindly note the following:

- The participation will be limited to 30 member companies with MAI support, but those who wanted to participate on selffinancing basis can also participate with upto date membership payment, having export performance in preceding year. The stand / display table area are heavily subsidized under MAI Scheme of Ministry of Commerce and preference will be given to MSE SC/ST/Women Entrepreneurs, Members from NE, J&K, Leh Ladhakh, start-ups;
- Applications will be finalized with due diligence and selection of exhibitors will be done by the in house Exhibition Committee and there decision will be final and binding, as per MAI guidelines;
- $\checkmark$  Any extra requirements in stands will have to be borne by the participants themselves;
- One company will be allocated one highly subsidized display stand booth area only;
- $\checkmark$  Amount of registration charge doesn't include any expenses of representative/s of participants companies like airfare, visa charges, freight, transfer, Covid vaccine & RTPCR / Rapid Antingen test charges, if applicable, in visiting cities of BSMs country etc;
- $\checkmark$  A small common pool of Interpreters will be made available at Council's Information Booth manned by the Council's Coordinator, for helping exhibiting participants and visiting buyers. However, for an independent service of an interpreter, participants will have to use their own interpreters; if they so desire;
- $\checkmark$  Participants will be provided visa recommendation letters (if so desire) in obtaining the Visas from the respect Missions only to the valid members;
- Publicity & Promotion: The event will be publicized extensively by the ISEPC. The Council will also publicize the Fair suitably through a separate Exhibitors Catalogue, sending invites to relevant textile importers in South Africa and adjoining economy, coordinate with the Indian Missions to promote the event to the leading importers of textiles & clothing, among other publicity measures.

#### Financial Grant:

As ISEPC is organizing participation of member-companies in Mega Silk Exhibition & Buyer Seller Meet at SA under the revised MAI Scheme 2021 of Govt of India, all eligible participating companies have been offered MAI subsidy for reduced amount of charge as above, subject to the fulfillment of certain conditions, laid down as under;

Companies having valid IEC Number, 6-digit HS Code, PAN, DIN, GST, etc. are eligible for MAI subsidy. The company which has already availed MAI subsidy for three previous participations in the same event will not be eligible for MAI subsidy. In the case of exporters belonging to SC/ST / Women and the exporters having f.o.b. value of exports of or less than Rs.50 crore in a year, 5 participations in a particular event is allowed. The company which has already availed MAI subsidy for any three events in FY 2022-2023 will also not be eligible for MAI subsidy. In the case of exporters belonging to SC / ST / Women and the preceding year, 5 participations in a year is allowed, provided each one of these is in different market (e.g. Africa, LAC, WANA, ASEAN, etc);

#### Criteria for availing subsidy and reimbursement of air fare:

- ISEPC will provide to all eligible participants re-imbursement of costs of airfares, subject to fulfillment of certain conditions with no dues pending. The reimbursement of cost of economy class airfare to eligible participants will be limited with a maximum ceiling, subject to approval of the Govt of India under the revised MAI Scheme;
- Reimbursement of airfare is eligible only to the exporting company as per the revised MAI Guidelines and should have export performance, having the export turnover below Rs 50 crores (FOB value) in the preceding financial year 2021-22, subject to furnishing of required documents with self-certification and approval of the same by the Govt. of India;
- Members to have completed one year of Membership with No outstanding dues;
- It is permissible only to the regular **Director / Partner/ Proprietor or a permanent officer** of the company on Senior **Managerial Position** (not admissible to a new employee and to a foreign national or a foreign passport holder);
- Travel Claim forms duly filled in and complete in all respects together with all documents as per MAI Guidelines, must be submitted to the Council within seven days of completion of event;
- Initial Application form for claiming re-imbursement of airfare should reach to Council 14 days prior to your departure date;
- An exporter can claim MAI benefit for participation in one booth only. Additional booths can be booked by the member participant without MAI support (One booth per company only for MAI eligibility with updated IEC); please attach a copy of IEC & RCMC;
- Participants will be selected on a "First-come-first-served" basis by the management of the Council. The Application will be received as its postponed activity of the last year and registration charges would remain same, per applicant per company, as above;

<u>Apply for participation</u>: Exporters registered with ISEPC can apply for participation with valid membership. Members interested in the above event are requested to kindly fill up and submit the "Application Form" together with a copy of updated and valid IEC & RCMC copy with registration fee & participation charges by way of Demand Draft / Cheque at par in favor of "The Indian Silk Export Promotion Council, payable at New Delhi. Incomplete unsigned / unstamped application will summarily rejected. The payment can also be sent through RTGS / NEFT as per the Bank details:

This rolled over activity is being done under revised MAI scheme and a postponed one and hence, all terms and conditions of the same will be applicable.

<u>Note</u>: If Council does not receive required number of applications from its members for the fair, then the ISEPC Management may take a decision to drop / postpone the activity / event.
