#### Eligibility for financial assistance under Market Access Initiative (MAI) scheme:

"A maximum of three participations in a particular trade fair/ exhibition would only be eligible for MAI assistance, i.e. members who have availed assistance three (3 times) **RPT Three times** (including past cases from any EPCs / Trade Bodies) for a particular fair / exhibition thereafter have to participate in that fair on their own. Further, MAI funding support shall only be provided to a member for a maximum of three MAI events in a year.

#### **Participation Charges:**

# This activity is being offered subject to MAI approval, otherwise normal price without MAI assistance will be applicable.

**Allocation of booth:** Allocation of booth will be done as per the product profiles of exhibitors in the respective halls on FCFS basis in the concerned section of the Fair.

<u>Visa</u>: Though participants will have to obtain their visa on their own, the Council shall, however, facilitate their efforts to get Visa on the basis of "Visa Recommendation Letter" with the help of the Organizer of the Show.

**In case of any variation in the rates,** the participation fee will be revised suitably. In view of the above, Interested Members / Exporters to participate in the July 2024 Edition of **Texworld Fair** may please submit their application with Registration fee and Participation by return mail, as the stands are very limited. Member Companies interested in corner booth are requested to kindly send us a separate cheque with application fee in favour of **The Indian Silk Export Promotion Council** payable at New Delhi along with Application / confirmation form. Incase corner booth is not allocated to interested member companies, then their cheque will be returned, as it is.

## In connection with your participation in TEXWORLD (Apparel Sourcing) show at Paris, kindly note the following important points:

- Any extra requirements will have to be borne by participants based on actual costs, as set out by the organizer
- One eligible company as per the revised MAI Guidelines will be allocated one booth only under the subsidized scheme of the Department of Commerce, Govt. of India;
- Amount of Registration / participation charges doesn't include any expenses of representative/s of participants companies like airfare, lodging and boarding, freight, insurance, visa, expenses etc.
- Exhibitor Participants will be given assistance for obtaining Visa from the concerned foreign Missions but preference will be given to valid visa holders;
- ➤ **Publicity & Promotion**: The event is being publicized extensively by the Organizers throughout the world. The Council will also publicize the Fair suitably through separate Exhibitors Catalogues, mailers, sending invites to relevant textile importers in Paris and nearby countries and coordinating with the Indian Mission at abroad to promote the event at their level also to the leading importers/suppliers/renowned international boutique owners/ departmental stores of textiles & clothing, high fashion accessories through among other publicity measures.

### Criteria for availing reimbursement of airfare as per the revised MAI Guidelines of Govt of India to the eligible participants only on approval of the same by Govt:

- ➤ Reimbursement of airfare is eligible to the exporting company having the export turnover below Rs.50 crores (FOB value) in the last financial year;
- Members to have completed 12 months of Membership with this Council and is regularly filing Export returns with us; Travel claim is permissible only to the regular Director / Partner/ Proprietor or a regular officer of the company on Senior Managerial Position, (not admissible to a foreign national); Attached Travel Claim forms duly filled in and complete in all respects must be submitted to the Council within 30 days of completion of event; Initial Application form for claiming reimbursement of airfare should reach to the Council 14 days prior to your departure date to participate in the fair;

#### Conditions for availing MAI subsidy:

- An exporter can avail MAI benefit for participation in 3 approved events in a financial year, 4th time participation in the Fair will be allowed without MAI subsidy on the rates as mentioned at SI No 3; (members may please submit self-declaration application);
- ➤ An exporter can claim MAI benefit for participation in one booth only. Additional booths can be booked by the member participant without MAI benefit (One booth per company only for MAI eligibility);
- > Participants will be selected on a "First-come-first-Served" basis; subject to approval of their products by the organizers;

**Apply for participation**: Exporters registered with ISEPC & with other EPCs / Trade Bodies can apply for participation in the above event are requested to kindly fill and submit the "**Declaration Form**" with participation fee by way of Demand Draft/Cheque at par in favour of "**The Indian Silk Export Promotion Council**, payable at New Delhi.
